#### **EXECUTIVE SUMMARY – ENGLISH**

NexGold Mining Corp. (NexGold), formerly Treasury Metals Inc. (Treasury), is proposing the construction, operation, decommissioning, and abandonment of an open-pit and underground gold mine and associated infrastructure. The Goliath Gold Project (Project), located 20 kilometres (km) east of the City of Dryden, Ontario, will have an anticipated mine and mill life of 13 years. Over the 13 years of operations, the average ore production and ore input capacity of the mine and mill would be 6,460 tonnes per day.

Treasury received a Federal government Decision Statement for the Project under the *Canadian Environmental Assessment Act, 2012* (CEAA, 2012) on 19 August 2019 (Decision Statement), with the Minister of Environment and Climate Change Canada concluding that, with the implementation of mitigation measures, the Project is not likely to cause significant adverse environmental effects referred to in subsection 5(1) CEAA, 2012.

As of 30 June 2025, NexGold had not announced a formal decision to advance the Goliath Gold Project. As such, the Project remains in the evaluation (design and planning) phase.

As per Condition 2.9, NexGold is required to prepare an annual report each reporting year (defined in the Decision Statement as July 1 to June 30) commencing the reporting year the decision statement was issued. As per Condition 2.10, NexGold has until October 31 following the reporting year to issue the report.

The purpose of this report is to satisfy Conditions 2.9 and 2.10 of the Decision Statement. It contains a project update, NexGold's approach to compliance management, an update on follow-up and adaptive management programs, the compliance status of federal decision statement commitments and a summary of key consultation and engagement activities.



## **SOMMAIRE EXÉCUTIF – FRANÇAIS**

NexGold Mining Corp. (NexGold), anciennement Treasury Metals Inc. (Treasury), propose de construire, exploiter, désaffecter et abandonner une mine d'or à ciel ouvert et souterraine ainsi que les infrastructures associées. Le projet aurifère Goliath (projet)—situé à 20 kilomètres (km) à l'est de la ville de Dryden, en Ontario—aura une durée de vie prévue de 13 ans pour la mine et l'usine. Au cours des 13 années d'exploitation, la production moyenne de minerai et la capacité d'entrée de minerai de la mine et de l'usine seraient de 6 460 tonnes par jour.

Le 19 août 2019, Treasury a reçu une déclaration de décision du gouvernement fédéral concernant le projet en vertu de la *Loi canadienne sur l'évaluation environnementale* (2012) (LCEE, 2012). Le ministre de l'Environnement et du Changement climatique du Canada a conclu qu'avec la mise en œuvre de mesures d'atténuation, le projet n'est pas susceptible d'entraîner des effets environnementaux négatifs significatifs visés au paragraphe 5(1) de la LCEE, 2012.

Au 30 juin 2025, NexGold n'avait pas annoncé de décision formelle pour faire avancer le projet aurifère Goliath. Le projet reste donc en phase d'évaluation (conception et planification).

Conformément à la condition 2.9, NexGold est tenu de préparer un rapport annuel pour chaque année de déclaration (définie dans la déclaration de décision comme allant du 1<sup>er</sup> juillet au 30 juin) à compter de l'année de déclaration au cours de laquelle la déclaration de décision a été émise. Conformément à la condition 2.10, NexGold a jusqu'au 31 octobre suivant l'année de déclaration pour publier le rapport.

Le but du présent rapport est de satisfaire aux conditions 2.9 et 2.10 de la déclaration de décision. Il contient une mise à jour du projet, l'approche de NexGold en matière de gestion de la conformité, une mise à jour des programmes de suivi et de gestion adaptative, l'état de conformité aux engagements de la déclaration de décision fédérale, ainsi qu'un résumé des principales activités de consultation et d'engagement.



#### 1.0 INTRODUCTION

NexGold Mining Corp. (NexGold), formerly Treasury Metals Inc. (Treasury), is proposing the construction, operation, decommissioning, and abandonment of an open-pit and underground gold mine and associated infrastructure. The Goliath Gold Project (the "Project"), located 20 kilometres (km) east of the City of Dryden, Ontario, will have an anticipated mine and mill life of 13 years. Over the 13 years of operations, the average ore production and ore input capacity of the mine and mill would be 6,460 tonnes per day. The regional location of the Project is shown on Figure 1.

As described in correspondence with IAAC on August 21, 2024, Treasury Metals Inc. changed its name to "NexGold Mining Corp." effective July 9, 2024.




Figure 2: Environmental Assessment Project Study Area

Treasury received a Federal government Decision Statement for the Project under the *Canadian Environmental Assessment Act, 2012* (CEAA, 2012) on 19 August 2019 (Decision Statement), with the Minister of Environment and Climate Change Canada concluding that with the implementation of mitigation measures, the Project is not likely to cause significant adverse environmental effects referred to in subsection 5(1) CEAA, 2012. The Minister's Decision Statement also established conditions in relation to the environmental effects, which must be complied with in order to advance the Project. NexGold is aware of the legal requirements and commitments made during the Environmental Assessment (EA) process and will ensure their implementation in a careful and precautionary manner. The EA Project Study Area is shown on Figure 2.

As of 30 June 2025, NexGold had not announced a formal decision to advance the Goliath Gold Project. As such, the Project remains in the evaluation (design and planning) phase. The follow-up programs required as per conditions 3.13, 3.14, 3.15, 4.5, 4.6, 4.7, 5.2, 5.3, 6.8, 6.9, 7.3, 7.4, and 7.5 are scheduled for development and implementation once the Project has moved past the evaluation phase, and into the pre-construction phase.

As per Condition 2.9, NexGold is required to prepare an annual report each reporting year (defined in the Decision Statement as July 1 to June 30) commencing the reporting year the decision statement was issued. As per Condition 2.10, NexGold has until October 31 following the reporting year to issue the report.

## 2.0 REPORT SCOPE AND REQUIREMENTS

The scope of this Annual Report is to outline how NexGold has complied with the conditions of the Decision Statement. This report covers the Project activities undertaken by NexGold during the cumulative reporting period, 01 July 2024 to 30 June 2025 inclusive (herein referred to as the "reporting period").

Condition 2.9 of the Decision Statement outlines the Annual Report information requirements for the Project. *Table 2-1* outlines the section references within this document that demonstrate concordance with these requirements.

#### 3.0 PROJECT UPDATE

This section provides a general update on the design and planning phase activities undertaken for the Project during the reporting period. The overall implementation schedule has been included to provide context for scope of this report and compliance reporting timeframes.

During the reporting period, NexGold commenced a Feasibility Study (FS) for the Goliath Gold Complex. The FS is being prepared in accordance with National Instrument 43-101 – Standards for Disclosure for Mineral Projects. Advancing technical engineering activities will provide the detail required for NexGold to move through the permitting process at a federal and provincial level, prior to advancing potential development at the Project. Baseline and technical studies, as well as community engagement, continue to support these activities.

NexGold has announced certain potential positive outcomes as it works towards the completion of its FS, including environmental protection and surface area optimizations. This work has resulted in the proposed reduction in the overall development footprint relative to the PFS. It is believed that there is potential to reduce the TSF surface area by up to 50% through the refinement of the mine plan. This change results in a reduction of waste rock volumes, potentially eliminating the need for the South Waste Rock Storage Area contemplated in the PFS. The reduction in the TSF surface area eliminates overprinting any waterways where fish are present; as such, a MDMER Schedule 2 amendment identified in the 2019 EA and PFS shall potentially no longer be required to advance the Project development. Optimization of mine sequencing will also potentially allow for earlier closure and remediation of the TSF and Waste Rock Storage Area, with the goal to be able to segment/isolate potentially acid-generating and non-acid-generating wastes as soon as possible. Enhancement to water management systems is expected to result in reduction and minimization of effluent discharges.

As of 30 June 2025, NexGold continues to advance technical engineering activities, and is working towards the completion of the FS.

NexGold continues to design and advance engineering details related to the Project in a manner that aligns with the company's corporate standards and policies. NexGold considers and incorporates the expertise of a team of qualified engineering and environmental consultants to support ongoing engineering and ongoing engagement with Indigenous communities.

NexGold is committed to continued compliance with the provisions of the Decision Statement throughout all Project phases. NexGold has begun preliminary development of an environmental management system with the aim of ensuring that EA, permit conditions and other commitments are implemented effectively.
