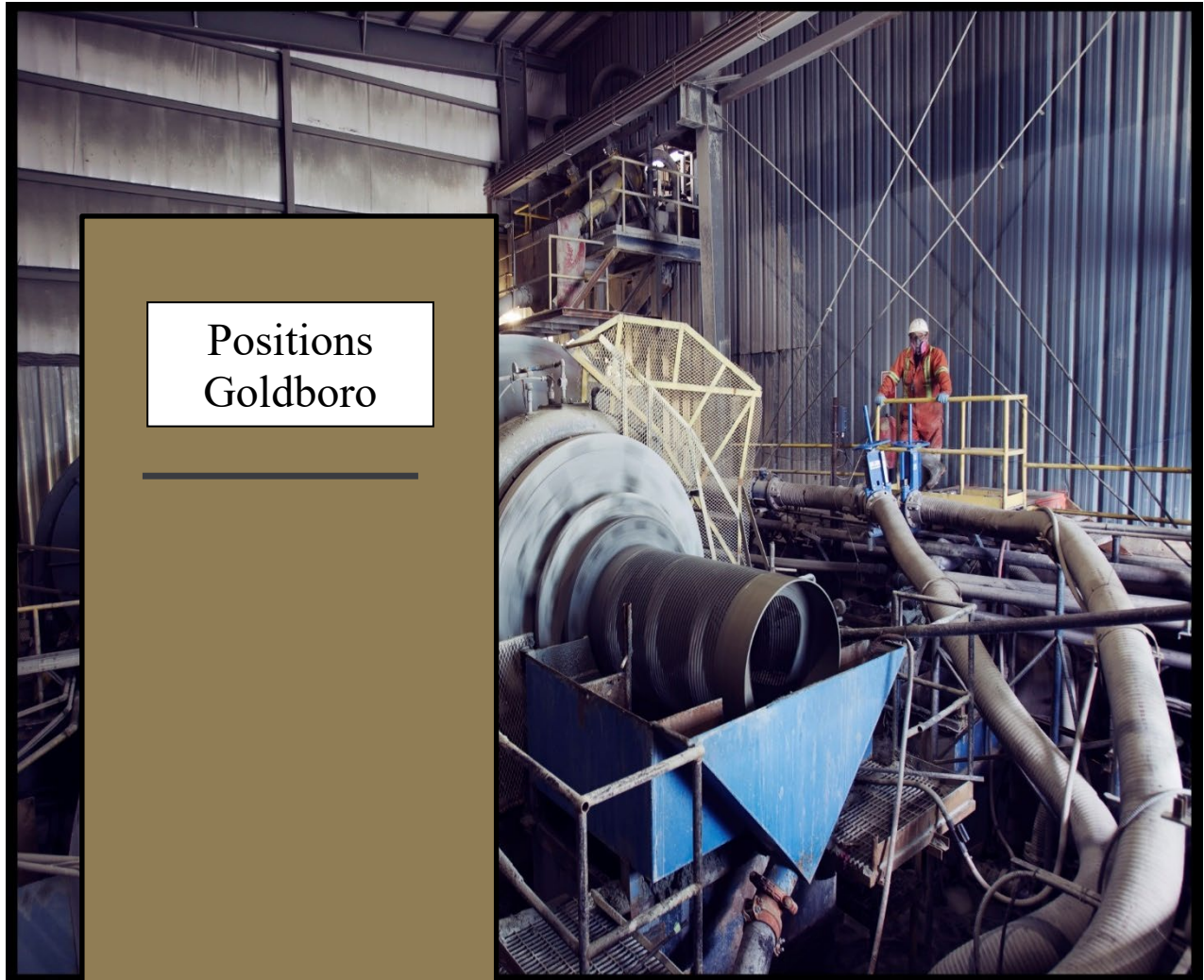

The Goldboro Gold Project

NexGold Mining Corp. is advancing its 100%-owned Goldboro Gold Project in Guysborough County, Nova Scotia, which is feasibility-stage. Goldboro hosts Proven & Probable Mineral Reserves of 1,150,200 oz Au (15.8 Mt at 2.26 g/t Au), Measured & Indicated Mineral Resources (inclusive of reserves) of 2.58 Moz Au (21.6 Mt at 3.72 g/t Au), plus Inferred Mineral Resources of 484,000 oz Au (3.18 Mt at 4.73 g/t Au).

The January 2022 Feasibility Study contemplates a conventional open pit operation (two pits) with a 4,000 tpd (1.46 Mtpa) process facility over a 10.9-year mine life, with average annual production of ~100,000 oz, average gold recovery of 95.8%, and total initial capital costs of C\$271.0M.

The Company has advanced key provincial and federal approvals for the Goldboro Gold Project. Provincially, Goldboro received Environmental Assessment approval (June 2022) and most recently received the Project's Industrial Approval (August 2025). Federally, the Project has received the required Schedule 2 amendment under the Metal and Diamond Mining Effluent Regulations (July 2025) and, most recently, the Fisheries Act Authorizations (FAAs) issued by Fisheries and Oceans Canada, which represent the final major federal approvals required prior to the commencement of construction and future operations (FAAs issued October 31, 2025; announced November 4, 2025). The Company originally applied for the FAAs in August 2023, the application was deemed complete in December 2023, and consultation was active throughout 2024 and 2025.
